## BANK DRAFT AUTHORIZATION FORM

The City of Pell City offers an easy and convenient way to pay your water bill. Through bank drafting, your monthly bill is withdrawn automatically from your checking and/or savings account. You will continue to be provided a monthly bill showing your current charges. Because payment is automatic, there are no late fees or postage costs. This service is provided to you free of charge.

### INSTRUCTIONS:

- Complete the authorization form below.
- To authorize payment from checking/savings account, provide account information along with a blank check marked **VOID**.
- Payments will be deducted from checking/savings account on the due date (15<sup>th</sup>) or the first business day following the due date. The applicable due date will be shown on your monthly utility bill.
- If we receive two (2) returned bank drafts as unpaid for any reason, you will be taken off the bank draft program. The customer will be charged a \$30.00 fee per each rejected ACH payment.
- Upon successful enrollment in the program, the first bank draft will occur at the next stated due date. If the enrollment form is received after the 10<sup>th</sup> of the month, the City will draft your account the following month on the due date or the first business day following the due date.
- You may cancel your participation at anytime by completing a "Bank Draft Cancellation Form" available at City Hall or online.
