#### INVITATION TO BID

In accordance with General Act No. 217, Special Session, notice is hereby given that the City of Pell City, Alabama, will receive competitive bids on the following items:

# 2016 SPRING SPORTS UNIFORMS (See Attached Specifications)

You are invited to bid on the above specifications. The right to reject any item or materials not of quality or under provisions of the Act is reserved.

As a condition for the award of a contract with the City of Pell City, a Contractor shall not knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama, and shall provide documentation to the City establishing that the Contractor is enrolled in the E-Verify program. As a condition for the award of a contract with the City, the contract must include the following clause:

"By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration laws or knowingly employ, hire for employment, or continue to employ an unauthorized alien with the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom."

In addition, as a condition for the award of a contract with the City, a Contractor shall execute a "Certificate of Compliance" with the Beason-Hammon Alabama Taxpayer and Citizen Protection Act, which is attached hereto.

Deadline to receive bids will be February 16, 2016 at 9:55 a.m. at City Hall. Bids will be opened on February 16, 2016 at 10:00 a.m. in the Council Chambers of City Hall, 1905 1st Avenue North, Pell City, Alabama.

All bids must be sealed. The words "SEALED BID" and "2016 SPRING SPORTS UNIFORMS", along with the date and time of bids, must be written on the lower left hand side of the envelope. If awarded, a city license is required along with proof of General Liability and Workman's Compensation Insurance (if applicable).
