ORDINANCE 2019 - 5166

AN ORDINANCE TO CHANGE THE CITY OF PELL CITY MUNICIPAL ELECTION POLLING PLACE

WHEREAS, Alabama law at Title 11-46-21, <u>Code of Alabama</u>, <u>1975</u>, provides that the regular municipal elections in cities and towns in Alabama shall be held on the fourth Tuesday in August 1984, and quadrennially thereafter and, when necessary as provided in subsection (d) of Title 11-46-55, second or runoff election to be held on the sixth Tuesday next thereafter following the regular election; and

WHEREAS, Alabama law at Title 11-46-24, <u>Code of Alabama</u>, <u>1975</u>, requires the municipal governing body designates voting places for municipal elections; and

WHEREAS, the City of Pell City Municipal Election polling place is now located at the Pell City Civic Center located at 2801 Stemley Bridge Road, Pell City, Alabama; and

WHEREAS, moving the Municipal Election polling place to Cropwell Baptist Church located at 2700 Hardwick Road, Pell City, Alabama, will allow the City of Pell City, Alabama, to upgrade said polling place and to provide a more comfortable environment for election officials and voters; and

WHEREAS, Cropwell Baptist Church is an ADA compliant facility; and

WHEREAS, state law allows the municipal governing body to change polling places no later than three (3) months before a municipal election.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Pell City, Alabama, as follows:

- 1. That the Municipal Election polling place is hereby moved from the Pell City Civic Center to Cropwell Baptist Church located at 2700 Hardwick Road, Pell City, Alabama.
- 2. That the City Clerk of the City of Pell City, Alabama is hereby authorized and directed to cause this Ordinance to be published one (1) time in a newspaper of general circulation in the City of Pell City, St. Clair County, Alabama.
- 3. That the City Clerk is hereby directed to deliver copies of this Ordinance to the St. Clair County Probate Judge and the St. Clair County Board of Registrars.
- 4. That this Ordinance shall take effect upon its adoption by the City Council and publication as required by law.
