The City Council of the City of Pell City met in a regularly scheduled work session at City Hall at 5:30 p.m. on Monday, June 14, 2021. Present were Council President Alverson, Councilmembers Jay Jenkins, Ivi McDaniel, Blaine Henderson, and Jason Mitcham. Those present constituting the entirety of the Council, Council President Alverson opened the meeting for discussion.

The invocation was led by Reverend Donald Gover.

The pledge to the American Flag was led by Councilmember Jason Mitcham.

The City Clerk had roll call for attendance.

There were no comments regarding the bills on file.

There were no comments on the minutes of the regular council meeting held on May 24, 2021.

City Manager Brian Muenger addressed the Council regarding the vacation of First Avenue North and Parker Avenue. Mr. Muenger advised the adjacent property owners waived their rights to service and confirmed both streets were undeveloped. City Attorney John Rea advised the intent was to clean up the lines for New Hope Baptist Church Cemetary. He advised the vacated property would be divided equally with the other property owners.

City Manager Brian Muenger addressed the Council regarding the dedication of an easement to Alabama Power Company for the restroom facilities that will be located in Glenn City Park. He advised a resolution would accompany the easement.

City Manager Brian Muenger addressed the Council regarding a leak credit request from Brotherly Love Lodge located at 1704 Blooming Light Road. He stated the request was straight forward and advised the large amount was due to the Church being closed due to Covid.

Jatinkumar Patel, who resides at 1216 Logan Martin Dam Road, addressed the cancel regarding his request to de-annex from the City Limits of Pell City. Mr. Patel advised he had tried several avenues to be able to develop the property he has purchased but does not have any access roads that would be allowed to enter the property. City Attorney John Rea advised that the standard was whenever in the opinion of the City Council, the public health or public good, the Council shall pass a resolution authorizing the de-annexation, which would then be filed with Probate Court. Mr. Rea further clarified that if the Probate Judge wished to call for an election that all costs would be borne to Mr. Patel. Mr. Patel advised that Dan Dahlke with St. Clair County advised the County was ready to install the road and advised the County lots would be developed first

City Manager Comments: Mr. Muenger advised the Council there was an invitation distributed to them and stated that Greg Cochran would be speaking at the event. Mr. Muenger also congratulated the Friends of the Pell City Animal Control Center on a grant in the amount of \$4,000.00 that was awarded.
