City Manager Brian Muenger addressed the Council regarding the bids received for the replacement of the fence at the Pell City Street Department. Mr. Muenger advised there were three bids received with the lowest bid received from Try Me Fencing. Greg Gossett, Street Department Superintendent, stated he had originally requested approximately \$25,000 for the removal and replacement of the existing fence. Mr. Gossett gave a brief description of the fence that was quoted and installed at the Pell City Street Department. Mr. Muenger confirmed the fence would provide 95% blockage at no additional cost and confirmed the fence post would be concreted into the ground.

Fire Chief Tim Kurzejeski addressed the Council regarding a mutual aid agreement for the Pell City Fire Department. Chief Kurzejeski advised the mutual aid agreement would be statewide. City Attorney John Rea confirmed the Fire Chief of each jurisdiction is tasked with deciding whether or not the Pell City Fire Department would respond.

City Manager Brian Muenger addressed the Council regarding an Amended Engineering Agreement with EEFS regarding Hazelwood Drive. Mr. Muenger explained the request was for a supplemental fee of twenty-six thousand dollars (\$26,000) with twenty-three thousand dollars (\$23,000) being allocated for general plan updates and an additional three thousand dollars (\$3,000) for acquisition of right-of-way.

City Manager Brian Muenger addressed the Council regarding the FY 21/22 appropriations. Mr. Muenger advised there was a late addition for a request received from the ARC of St. Clair County.

City Manager Comments: Mr. Muenger spoke briefly regarding the ALDOT project that was being conducted by Spire on 19<sup>th</sup> Street South and confirmed the project was affecting the sidewalks that were installed a few years ago as well as the paving of the City Property located on 19<sup>th</sup> Street. He advised that it was confirmed all damaged areas would be returned to its original state.
