5. What goals should the Pell City Board of Education to prioritize over the next 3-5 years? Include things you think Pell City Schools are doing well and should be supported, and things you would seek to improve.

Initial priority should be given to strengthen Career and Technical Education (CTE) Programs. Pell City should continue expanding career pathways, including entrepreneurship, business, and STEM-related programs, to prepare students for the workforce and college. Enhancing technology integration and investing in modern classroom technology and digital learning tools will better prepare students for an evolving job market.

Secondly, the board of education should prioritize an increase in teacher support and retention. Prioritizing competitive salaries, professional development, and mentoring programs will help retain high-quality educators and improve student learning outcomes.

Lastly, the board of education should expand community and business partnerships. Strengthening ties with local businesses and colleges can provide internships, apprenticeships, and dual enrollment opportunities for students.

If the Pell City School Board expands community and business partnerships by 50% in the next year, it could make the other two recommended priorities unnecessary. I would seek to develop and launch a Pell City Schools Business & Innovation Council (BIC). By creating a structured Business & Innovation Council, the board of education could:

- 1. Enhance Career & Technical Education (CTE) Businesses would directly shape curriculum, provide internships, apprenticeships, and real-world learning experiences.
- 2. Increase Teacher Support & Retention Local businesses could sponsor teacher training, provide incentives, and offer real-world business education support.
- 3. Improve Technology Integration Tech companies in the region could donate equipment, offer software training, and provide guest lectures.
- 4. Drive Fiscal Efficiency By leveraging private-sector funding, sponsorships, and in-kind donations, the district could reduce dependence on traditional tax-based funding.

If Pell City Schools expands business partnerships 50% through this initiative, students will get career-ready faster, teachers will be supported by business sponsors, and technology investments will flow from the private sector. The school system will be less dependent on tax increases or state funding, making space for the board of education to support and prioritize other school initiatives.
